# **Conflict Transformation Skills:**

Augsburger, David. *Conflict Mediation Across Cultures: Pathways and Patterns*. Louisville, KY: Westminster/John Knox Press, 1992. Pp. 310. \$26.00.

Focuses on the unique methods individual cultures use in resolving conflict – on the frequent need to modify our own assumptions about right and wrong ways of dealing with conflict when in another culture.

Augsburger, David. Helping People Forgive. Louisville, KY: Westminster/John Knox Press, 1996. Pp. 180. \$30.00.

The complicated issues of Christian forgiveness and reconciliation and their real-world applications are explored from a variety of theological and theoretical perspectives.

Bartel, Barry C. *Let's Talk: Communication Skills and Conflict Transformation*. Newton, KS: Faith and Life Press, 1999. Pp. 80. \$11.00.

An excellent resource for senior high school and adult Christian education classes, this workbook's ten chapters outline basic communication and conflict transformation skills. Includes a guide for leaders.

Beer, Jennifer & Packard, Caroline with Stief, Eileen. *The Mediator's Handbook.* Canada. New Society Publishers, 2012. Pp. 194. \$34.99 (on Amazon).

This handbook offers a model for helping people work through conflict. Beer, Packard and Stief unpack the skills needed to understand conflict, support the people in conflict, facilitate the process, and guide decision making. This tried and tested textbook has assisted students and professional mediators alike in knowing how to mediate a conflict effectively.

Fisher, Roger and Ury, William. *Getting to Yes: Negotiating Agreement Without Giving In.* New York, NY: Penguin Books, 1983. Pp. 161. \$17.00.

A straightforward, universally applicable method for negotiating personal and professional disputes without getting taken – and without getting nasty. Outlines the theory of interest-based bargaining.

Grant, Adam. *Think Again: The power of knowing what you don't know.* New York, New York. Viking, 2021. Pp. 320. \$16.75 (on Amazon).

Grant examines the art of critical thinking to promote life-long learning. It teaches that no matter how skilled you are, there is always room to learn more. He establishes a need for curiosity that would benefit individuals by becoming more openminded, investigative, and learned, all while embracing the joy of being wrong. This is a book for anyone, anywhere, who finds value in wisdom, not just knowledge

Hocker, Joyce & Wilmot, William. *Interpersonal Conflict*. New York, New York. McGraw-Hill Education, 2022. Pp.393. \$74.98 (on Amazon).

This textbook explains the key dynamics of personal conflicts that everyone faces. Examining the principles of effective conflict management, this textbook gives insight into the theory and practice of such an important factor in the process of peacemaking.

Kahneman, Daniel. *Thinking, Fast and Slow.* New York, New York. Farrar, Straus and Giroux, 2013. Pp. 499. \$11.29 (on Amazon).

Kahneman writes about the two Systems in our thinking track: System 1 (emotional, fast, reactive), and System 2 (logical, slow, deliberate). He writes about how we can master these thinking tracks to be more thoughtful in our approach to work, at home, and elsewhere. This book is for anyone who wants to take active responsibility for their reactivity and harness the ability to slow down and truly think through their thoughts and actions.

Kraybill, Ronald S., Evans, R. and Frazer Evans, A. *Peace Skills: Manual for Community Mediators*. San Francisco, CA: Jossey-Bass Inc., 2001. Pp. 137. \$26.00.

The book provides a foundation for a training workshop in conflict transformation, as well as offering additional reading for participants of such workshops. Beginning with the basics of conflict transformation, the core of the manual presents the various stages in the mediation process with clarity and some depth.

Lederach, John Paul. *Reconcile: Conflict Transformation for Ordinary Christians.* Scottdale, PA: Herald Press, 2014. Pp. 190. \$15.00.

The author shares insight from years of work in international mediation and deep spiritual reflection on the task of reconciliation. From personal experiences and the biblical story, he finds God seeking reconciliation throughout history.

Lederach, John Paul. *The Little Book of Conflict Transformation*. Intercourse, PA: Good Books, 2003. Pp. 74. \$6.00.

A clearly articulated statement that offers a hopeful and workable approach, laying out the vision for conflict transformation, as opposed to conflict resolution.

Mock, Ron, editor. *The Roleplay Book: 41 Hypothetical Situations*. Akron, PA: Mennonite Conciliation Service, 1997. Pp. 123. \$18.00.

The Roleplay Book is a resource for trainers in mediation and other forms of conflict transformation. It provides a valuable resource for graduates of LMPC's Mediation Skills Training Institute who want to keep their skills finely tuned.

Schrock-Shenk, Carolyn and Ressler, Lawrence, editors. *Making Peace With Conflict: Practical Skills for Conflict Transformation*. Scottdale, PA: Herald Press, 1999. Pp. 198. \$15.00.

A practical guide to understanding and transforming conflict based on biblical and Anabaptist principles. Over twenty noted authors shaped by many experiences and cultures tell of lessons taught by walking conflict's holy ground. Includes a chapter on *Conflict in Congregations* co-authored by Richard Blackburn, LMPC Executive Director.

- Smith, Kathleen. Everything Isn't Terrible: Conquer your insecurities, interrupt your anxiety and finally calm down. New York, New York. Souvenir Press, 2019. Pp. 224. \$14.59 (on Amazon). Smith offers practical ways to help build a more confident self to help calm down family dramas, community mishaps, and other areas of anxiety.
- Smith, Kathleen S. **Stilling the Storm: Worship and Congregational Leadership in Difficult Times.** Lanham, MD: Rowman & Littlefield Publishers / Alban Books, 2006. Pp. 229. \$23.00.

A book for anyone seeking a deeper understanding of the ways that worship intertwines with the life and health of a congregation explores the issue of worship in the context of three main types of difficulty congregations can face: times of crisis, transition, and conflict.

Zehr, Howard. *Changing Lenses: A new focus for crime and justice.* Scottdale, PA. Herald Press, 2003. Pp. 292. \$19.99 (on Amazon)

In this book, Zehr proposes a "restorative" model which is more consistent with experience, with the past, and with the biblical tradition. Based on the needs of victims and offenders, he takes into account recent studies and biblical principles.

Zehr, Howard. *The Little Book of Restorative Justice.* Interciurse, PA. Good Books, 2002. Pp. 74. \$5.99 (on Amazon).

Zehr proposes workable principles and practices for making Restorative Justice possible in the face of wrongdoings. Topics in this book include: three pillars of restorative justice; the "who" and the "how" are important; the goals of restorative justice; and that core approaches often involve an encounter.

   Describes successful evaluation models, focusing on the need for pastoral and congregational evaluations.
- Mead, Loren B. *A Change of Pastors: And How It Affects Change in the Congregation.* Lanham, MD: Rowman & Littlefield Publishers / Alban Books, 2014. Pp. 100. \$17.00.

A revised and updated edition of *Critical Moment in Ministry: A Change of Pastors*, which suggests that the time of transition from one pastoral leader to the next pastor affords a unique opportunity for change of the congregation itself, not just of its pastor.

Noble, Cinnie. *Conflict Management Coaching: The Cinergy Model.* New Haven, CT. 2012 Cinergy Coaching, 2011. Pp. 280. \$27.00 (on Amazon).

Noble offers insight that coaches, mediators, and other conflict professionals could learn from. Covering the three pillars of conflict management coaching, client engagement, skills for conflict management coaching, applications and assessment, Noble creates a concise book as a tool to guide and implement.

Oswald, Roy M. *New Beginnings: A Pastorate Start Up Workbook*. Lanham, MD: Rowman & Littlefield Publishers / Alban Books, 2014. Pp. 82. \$18.00.

Focuses on issues for pastors in new settings: role clarity, getting along with people, taking care of self, etc.

Stokes, Allison. *Shalom, Salaam, Peace.* New York, New York. General Board of Global Ministries, 2006. Pp. 190. \$14.50 (on Amazon).

With 44 page study guide that presents 4 two hour lessons plans, one for each section of the book, as well as advice for study leaders. About the book, Dr. Eboo Patel writes, "Shalom, Salaam, Peace is poetic yet practical, intellectual yet accessible, unabashed about its roots in the Christian tradition while it lovingly explores shared values with other faiths. A clear and compassionate guide for confusing times."

White, Edward A. **Saying Goodbye:** A Time of Growth for Congregations and Pastors. Lanham, MD: Rowman & Littlefield Publishers / Alban Books, 2014. Pp. 114. \$18.00.

Stories and learnings from pastors in every stage of separation from a congregation, whether caused by a new call, a change of vocation, retirement, conflict, or the death of a church.

  Brown writes about the closeness of individuals and the relationships those individuals have. It highlights the important fact that we are not alone, but we still require self-awareness. She writes about how to help others around us without overstepping, while drawing from Bowen family systems theory.

Provides an important family systems perspective on church dynamics. Sections focus on families within the congregation, the congregation as a system, and the clergy family.

A collection of Friedman's essays that had been previously published in various journals or presented at various conferences, rich in wisdom and humor.

Friedman, Edwin H. What Are You Going to Do With Your Life? New York: Seabury Books, 2009. Pp.185 \$22.95.

A collection of writings – most previously unpublished – from the acclaimed writer, rabbi, and therapist regarding personal growth, development, and fulfillment.

  - Widely used by both family therapists and all health care professionals, the genogram is a graphic way of organizing the mass of information gathered during a family assessment and finding patterns in the family system for more targeted treatment.

Based on Bowen family systems theory, this book shows parents how to build healthy connections with children. Practical examples and stories illustrate familiar situations and concerns.

Using story, analysis, and scriptural reflection, Set Free offers a valuable resource towards dismantling racism.

Docherty, Jayne. *The Little Book of Strategic Negotiation.* Intercourse, PA. Good Books, 2005. Pp. 90. \$5.99 (on Amazon).

Docherty writes about negotiation in a way that is different from our normal assumptions of the work of a negotiator. This book is about the negotiation that happens in heated personal/social settings: deciding which parent will have custody of their child while a divorce is underway; bargaining between workers and management during the course of a merger and downsizing; or establishing a new government as a civil war winds down.

This book offers clear and strategic practices for pursuing a just peace. This process calls for long-term planning, working at all levels of society, careful decision-making, and coordinating different actors and approaches to peacebuilding, all things this book addresses.

Sen, Amartya. *Identity and Violence: The illusion of destiny.* New York, New York. W.W. Norton & Company, 2007. Pp. 240. \$11.99 (on Amazon).

Sen writes to challenge the reductionist division of people by race, religion, and class. He presents an inspiring vision of a world that can be made to move toward peace as firmly as it has spiraled in recent years toward brutality and war.

**Steadfast Hope: The Palestinian Quest for Just Peace.** The Palestine Israel Network of the Episcopal Peace Fellowship, 2011. Pp. 49. \$10.00.

Steadfast Hope challenges common myths and misperceptions about the origins of the Israeli-Palestinian conflict, presents a compelling snapshot of the present situation on the ground, and offers a guide to the challenges that lie ahead in the quest for peace

Wink, Walter. *Jesus and Nonviolence: A Third Way.* Minneapolis, MN. Fortress Press, 2003. Pp. 128. \$9.99 (on Amazon).

Wink uses what we know about Jesus and his way of nonviolence to shape this book into a message against the current alternative impacting society today. He writes about the possibility of victory for nonviolence if people refuse to resort to violence or terror in order to obtain their desires.

Offers a compelling collection of essays from experts who have consulted, taught, or written about clergy misconduct. Written for the pastor who must follow in the wake of prior misconduct, the book is also helpful for denominational officials and lay leaders of congregations that have experienced the misconduct of a pastor.

#### **Personal Stories:**

Brown, Austin. *I'm Still Here: Black dignity in a world made for whiteness.* New York. Convergent Books, 2018. Pp. 192. \$11.53 (on Amazon).

This book shares the story of Austin Brown, a black woman navigating a white America. Austin shares her experiences in her school, her church, and her community. By addressing the areas of discrimination, conflict, and trials she has faced, this book is a guiding light for readers to listen and respond.

Hill, Marc. *Nobody: Casualties of America's War on the Vulnerable, from Ferguson to Flint and Beyond.* New York, New York. Atria Paperback, 2017. \$9.69 (on Amazon).

This book offers an analysis State-sanctioned violence in some high profile deaths in America. Hill writes to help readers understand the plight of vulnerable communities, examines the effects of unfettered capitalism, and political power in a country that boasts freedom.
